

Important to know about and do during treatment

To achieve the best results, it is important that you follow our instructions carefully. Otherwise, we may have to cancel the treatment and contact the property owner for further action.

Important to do before treatment



We need access to **all** areas in order to inspect them.



Vacuum floors, cracks, cavities as well as kitchen equipment. Wash floors with detergent.



After vacuuming, place the dust bag in a plastic bag and put it in the freezer. Wait at least seven days, remove the bag and dispose of it as regular household waste.



Clean behind and under the microwave, cooker and fridge as well as inside cupboards and drawers.



Wash-up dishes – plates, cups, cutlery etc. – and put them away in cupboards and drawers.



Store all food in containers with tight or screw-on lids. Remove or cover food left out for pets, after they have eaten



Place food that has been contaminated in a plastic bag and put it in the freezer. Wait at least seven days, remove the bag and dispose of it as regular household waste.



Keep all household waste and compost in containers that have lids.



Thoroughly clean the bathroom drain and underneath the bath tub



During treatment

Bait treatment:

Usually the treatments are carried out with bait, which means that you can use those areas as normal immediately after treatment.

Spray or powder treatment:

Occasionally we need to use liquid powder or powdered products. If this is the case our pest technician will inform you of this and give you specific instructions:

- No one may enter rooms which we have treated for a period of two hours. However, it is possible to be in adjacent rooms.
- When the product has dried (this can take up to 24 hours), the treated areas can be used again. Any items that have been removed, can also be put back.
- People with hypersensitivities such as asthma/ allergies, children under the age of two, pregnant women and household pets should not spend prolonged periods of time in treated rooms whilst any odour still persists
- Do not clean treated surfaces for five weeks. Our products will then continue to have an effect on insects that come into contact with those surfaces.



Generally

- Under no circumstances should you clean or move the bait traps and pesticides that we have put out. They help us to map out, among other things, where the insects are and how large the contamination is.
- Do not use your own pesticides as this can limit the affect or completely destroy the sanitation work we have started.



 Treat contaminated food by placing it in a plastic bag in the freezer (-18° C). Wait at least seven days, remove the bag and dispose of it as regular household waste.

About the treatment

We help you to resolve problems with cockroaches and pharaoh ants as soon as possible. However, despite using modern methods that are effective, it can take up to a week before they start showing results.

This is how the process works:

Mapping

We inspect, and place bait traps and pesticides.

Treatment period

You will begin to notice dead insects during the treatment period in the treated areas.

Conclusion

Now there should be no further signs of insects. If necessary, we will arrange a return visit in order to inspect and/or renew some parts of the treatment.
